If you don't upload, fax or mail your Response form and supporting documentation within **30 days** from the date of this notice, we'll send you an audit report proposing to disallow the items being audited as not sufficiently documented along with proposed changes to your tax return.

- If the information supports your tax return, we'll send your refund and a letter letting you know your audit is closed.
- If the information doesn't fully support your tax return, we'll send you an audit report that explains the proposed changes, including any additional tax you may owe plus any penalties and interest that may apply.

## Taxpayer rights and sources for assistance

#### **Taxpayer Advocate Service**

The Taxpayer Advocate Service (TAS) is an independent organization within the IRS that helps taxpayers and protects taxpayers' rights. TAS can offer you help if your tax problem is causing a financial difficulty, you've tried but been unable to resolve your issue with the IRS, or you believe an IRS system, process, or procedure isn't working as it should. Tax professionals who are independent from the IRS may be able to help you.
