Important Taxpayer Notification

Dear Taxpayer:

We have received your tax return and wish to inform you of inconsistencies we discovered as it was being processed.

On the back of this notification is a line-by-line breakdown of your return. The left column shows the figures as reported on the return. The right side reflects the figures as we have calculated or adjusted them. These adjustments are followed by a brief description. The changes may have altered the amount of your refund due or resulted in an additional amount owed.

Please review your return and calculations to ensure we have not made any errors. If you do not agree with this notification, within 20 days you should submit to the Department an explanation and any verification supporting your disagreement. Once your documentation is received, please allow 8 to 12 weeks for additional departmental research and review.

If you agree with the proposed changes you will either receive a refund in the adjusted amount or a NOTICE OF TAX DUE that will reflect the additional tax. This NOTICE may include a penalty of 10% and interest that accumulates daily. (Payments received prior to April 15 of the tax year will not be assessed penalty or interest.) If you have protested this notification, submitted your disagreement and later receive a NOTICE OF TAX DUE, you should notify the Department to ensure your documentation was received.

If you agree with this notification and you wish to make payment at this time, you should **use the coupon** on the back to guarantee your account is properly credited. If after 20 days you do not submit the full amount due, the NOTICE OF TAX DUE will be issued.

If a refund was calculated you will receive the amount in the next few days. If after reviewing any additional information provided by you results in further adjustments, you will be issued a second refund for the difference. As stated above any adjustments resulting in an additional amount due will generate a NOTICE OF TAX DUE.
